Rules for the Promotion Action "Top Up Bonus"

The Promotion Action "Top Up Bonus" (hereinafter referred to as the Promotion Action) is held by Humans Limited Liability Company, address: 100047, Republic of Uzbekistan, Tashkent, Makhtumkuli street, 2 B, Taxpayer Number (INN) 306624856 (hereinafter referred to as the Provider), and is aimed at attracting new subscribers, increasing interest in Provider's communication services, concluding communication services contracts with the Provider and increasing the level of use of Humans mobile app.

- 1. Information about the Promotion Action
- 1.1. Capitalized words used in the text of these Rules are the terms. The definition of these terms is given in HUMANS Communication Services Conditions and Humans Loyalty Program approved by the Provider and published on the web-site www.humans.uz, unless otherwise specified in these Rules.
- 1.2. Participants of the Promotion Action are the Clients individuals who have entered into the Communication Services Contract with the Operator by accepting the terms and conditions of Humans communication services, and have performed other actions listed in section 2 of these Rules.
- 1.3. Territory of the Promotion Action: the Republic of Uzbekistan.
- 1.4. The Promotion Action period: from Jan. 28, 2021 to Apr. 15, 2021
- 2. Description of the Promotion Action
- 2.1. During the Promotion Period and subject to the conditions specified in clause 2.2 of the Promotion Rules, the Promotion Participant receives a Bonus in the amount of 10% (ten percent) of the cost of the connected tariff package and Unlimited Apps Options, as well as the Unlimited Message Option (depending on what is connected) to Cashback account (hereinafter referred to as the Bonus)..
- 2.2. Terms of Promotion Action.
- 2.2.1. Participants who meet the following requirements can take part in the Promotion:
 - -the Participant has a Tariff package with a billing period of 30 days, worth more than 0 UZS;
 - -the Participant has an automatic renewal of the Tariff package;
- -1 hour and more have passed since the end of the next Settlement Period for the Tariff Package.
- 2.2.2. During the period of the Promotion, Participants who meet the requirements specified in clause 2.2.1. are credited with a Bonus when replenishing the Participant's Personal account in an amount sufficient to automatically renew the current Tariff package, taking into account the cost of Unlimited Apps Options, as well as Unlimited Message Option (if its are connected), as well as taking into account the balance of the Participant's Personal account.
- 2.3. The Bonus is credited at the time of automatic renewal of the connected Tariff to the Participant's Cashback account.
- 3. Final Provisions
- 3.1. These Rules come into force from the moment they are published on the Provider's website. The Provider has the right to unilaterally amend these Rules or cancel the Promotion Action, having previously notified about it by posting a corresponding notice on the website. The notification date is the date when the relevant information is published on the website. The Rules are considered amended, and the

Promotion Action is canceled from the moment when the relevant information is published on the website.

- 3.2. The Client's fulfilment of the actions specified in section 2 of the Rules means full and unconditional acceptance of these Rules, which are the Offer addressed to individuals.
- 3.3. If the Participant cancels or changes the amount of the payment, Humans has the right to cancel the Bonus accrual to the Cashback account.
- 3.4. For the rest, not regulated by these Rules, the Rules of the Humans Loyalty Program apply.
