Promotion rules "5% Cashback for purchases with Humans VISA bank card in "Korzinka", "Baraka Market", "Makro Supermarket" network (new version)

Promotion Accrual of 5% Cashback for purchases with bank card Humans VISA in network "Korzinka", "Baraka Market", "Makro Supermarket" (hereinafter referred to as the Action) is held by the Limited Liability Company "Humans", address: 100047, Republic of Uzbekistan, Tashkent city, Makhtumkuli street, 2 B, tax identification number 306624856 (Humans), in the framework of the Loyalty program Humans.

1. INFORMATION ABOUT THE PROMOTION

- 1.1 Capitalized words used in the text of these Rules are terms. The meaning of the terms is given in the Rules of the Humans Loyalty Program posted on the Website www.humans.uz, unless otherwise defined in these Rules.
- 1.2 Participants of the Promotion individuals who have entered into the Communication Services Agreement with Humans, as well as who have entered into the Humans Financial Services Agreement with Ravnaq-bank JSC, on the basis of which the Participant has been issued a Humans Visa card, and who have performed the actions specified in Section 2 of the Rules.
- 1.3 Territory of the Promotion: The Republic of Uzbekistan.
- 1.4 New Campaign period: from 25.05.2023 indefinitely until it is cancelled.
- 1.5 Payment for the purpose of these rules of the Action, Payment means execution of Client's financial liabilities to partners for the purpose of goods payment with the help of bank cards Humans Visa.
- 1.6. Promotion Partners are Anglesey Food LLC stores operating under the "Basket" and "Smart" brands, including Goods purchased through the Lebazar store. URBAN RETAIL LLC stores operating under the "Baraka Market" brand. Stores of LLC "DARVOZA SAVDO" working under the brand name "Makro Supermarket". DISKONT "Basket" supermarkets located at the addresses do not participate in the action: Republic of Karakalpakstan, Nukus city, Ernazar Alakuz street, 162 and Kashkadarya region, Shakhrisabz city, Maftunkor street, 35.

2. DESCRIPTION OF THE PROMOTION

- 2.1 During the Period of the Promotion and subject to compliance with these Rules, the Participants of the Promotion shall receive a Cashback of 5% of the amount of the Payment, using the Humans Visa bank card, for the Goods purchased from the Partners.
- 2.2 Participants, who are current participants of the Humans Loyalty Program, whose participation in the Humans Loyalty Program has not been suspended or terminated, can participate in the Promotion.
- 2.3 The Participant may used the received Cashback strictly according to the conditions of Humans loyalty program and he can't reseive Cashback in money.
- 2.4 The Participant can use the received Cashback strictly in accordance with the terms of the Humans Loyalty Program and cannot receive Cashback in money.
- 2.5. In the event of cancellation of the Payment (cancellation of the purchase of Goods from the Partners), the accrued Cashback will be cancelled and deducted from the Cashback account of the Participant of the Promotion.

3. FINAL STATEMENTS

- 3.1 These Rules come into force from the moment they are published on the Humans Website. Humans has the right to unilaterally modify these Rules or cancel the Promotion, notifying it by posting the relevant notice on the Website. The date of notification shall be the date the relevant information is posted on the Website. The Rules shall be deemed to be amended and the Promotion shall be deemed to be cancelled from the moment the relevant information is published on the Website.
- 3.2 Making Payments by the Participant using the Humans VISA card means full and unconditional agreement with the Rules, which is an offer addressed to individuals.
- 3.3 The Rules of the Humans Loyalty Program shall apply in all other respects not regulated by these Rules.
