RULES OF THE HUMANS' PROMOTION (GIVEAWAY) "IPHONES GIVEAWAY"

August 31, 2023

1. General provisions

- 1.1. The Organizer of the Giveaway: Limited Liability Company "Humans", address: 100047, Republic of Uzbekistan, Tashkent city, Makhtumkuli street, 2 B, TIN 306624856 (Humans) (Organizer).
- 1.2. Capitalized words used in the text of these Rules are terms. The meaning of the terms is given in the Rules of the Humans Loyalty Program, Rules of Use of the "Humans' Showcase of Goods and Services" service, available on the Website www.humans.uz, unless otherwise defined in these Rules.
- 1.3. The Giveaway is aimed at attracting new subscribers, increasing sales of the Organizer's services.
- 1.4. Individuals can take part in the Giveaway, if they concluded a Contract for the provision of Communication Services with the Organizer, as well as concluded a contract for the provision of financial services to Humans with Ravnaq-bank JSC, on the basis of which a Human Visa bank card was issued to the Participant, as well as performed the actions specified in clause 2.1 of the Rules (hereinafter referred to as the "Participant").
- 1.5. The fact of the Participant's participation in the Giveaway implies that the Participant is familiar with these Rules and agrees to participate in the Drawing in accordance with these Rules.
- 1.6. Period of the Giveaway is from 04.09.2023 to 01.10.2023.
- 1.7. Territory of the Giveaway is the Republic of Uzbekistan.
- 1.8. The Organizer awards the prizes specified in Section 5 of these Rules (hereinafter referred to as "Prizes") to Participants recognized as Winners in accordance with these Rules.

2. Procedure and conditions of participation in the Giveaway

- 2.1. During the period of the Draw, the Participant must perform a set of the following actions:
- 2.1.1. Make at least 2 (two) Payments to Partners during one day, in the categories specified in paragraph 2.3 below, with a Human Visa Bank Card in the amount of at least 100,000 UZS each.
- 2.2. One person can become the winner only once during the entire period of the Giveaway.
- 2.1.2 Making 2 (two) payments meeting the requirements specified in paragraph

- 2.1.1, the Participant receives 1 (one) "chance" to become the winner of the Giveaway. 2.1.3 The Participant can get an unlimited number of "chances" within one calendar day.
- 2.3 The Drawing applies to Partners belonging to the following categories (MCC codes):
 - 5411 Grocery stores, supermarkets
 - 5814 Fast food
 - 5812 Places of public catering, restaurants
 - 5813 Bars, cocktail bars, discos, nightclubs and taverns places where alcoholic beverages are sold
 - 5811 Caterers
 - 5441 Confectionery
 - 5462 Bakeries
 - 5311 Department Stores
 - 5422 Sale of fresh and frozen meat
 - 5451 Retail sale of dairy products
 - 5499 Various grocery stores not classified anywhere else
 - 5999 Different stores and specialty retail stores
 - 5331 Department stores
- 2.4. The set of actions specified in paragraphs 2.1. and 2.3 of these Rules is recognized as the Participant's application for participation in the Giveaway, in which the Participant becomes a contender for the Prizes specified in section 5 of these Rules.
- 2.5. The Organizer reserves the right to exclude a Participant from participating in the Giveaway if their unfair behavior is revealed.

3. Terms of the Giveaway

- 3.1. The Giveaway is held in the period from 04.09.2023 to 01.10.2023.
- 3.2. The winners of the Giveaway are determined weekly during the period of the Giveaway from 11.09.2023 to 08.10.2023.
- 3.3. Prizes are transferred to the winners no later than 08.10.2023.

4. Determining the winners of the Giveaway

4.1. The winner is determined weekly on the days specified in Section 3 of these Rules.

- 4.2. The winners are the Participants determined by the results of a random sample and who meet the criteria set out in paragraphs 2.1. 2.3 of these Rules. The organizer engages a third-party contractor, who randomly selects a number to determine the choice of 2 (two) Winners each week of the Giveaway.
- 4.3. Within the time limits specified in clause 3.2. of these Rules, the Organizer notifies the Winners about winning the Giveaway through posts in the @humans.uz account on Instagram.

5. Prize fund of the Giveaway

- 5.1. As a Prize, each Winner is awarded an iPhone 14, 256Gb device.
- 5.2. The winner does not have the right to demand payment of the monetary equivalent of the Prize instead of issuing the Prize in kind. The Organizer does not pay the monetary equivalent of the Prize value and does not replace the Prize.
- 5.3. The right to receive the Prize cannot be transferred by the Winner to another person.

6. Final provisions

- 6.1. The results of the Giveaway are final and are not subject to revision.
- 6.2. When preparing, conducting and participating in the Giveaway, violation of the legislation of the Republic of Uzbekistan and these Rules is not allowed.
- 6.3. These Rules can be changed or the Giveaway can be canceled by the Organizer with the notification of Participants on the website humans.uz. The Rules are considered canceled or changed from the date of publication of the relevant news on the Organizer's Website.
