

## Introduction of the rules for the "100% cashback when paying for the web version of the Kundalik e-diary" promotion (revised).

The promotion "100% cashback when paying for web version of the e-diary Kundalik " in the mobile application Humans and on the website Kundalik.com is a promotion of the Limited Liability Company "Humans", address: 100047, Republic of Uzbekistan, Tashkent city, Makhtumkuli street, 2 B, TIN 306624856 (Humans), within the Loyalty Program Humans.

### 1. Information about the Promotion

1.1 Capitalized words used in the text of these Rules are terms. The meaning of the terms is given in the Rules of the Humans Loyalty Program, Rules of Use of the "Humans' Showcase of Goods and Services" service, available on the Website [www.humans.uz](http://www.humans.uz), unless otherwise defined in these Rules.

1.2 Participants of the Promotion are individuals, who are users of the "Showcase of Goods and Services Humans" service, who have linked their bank card in the mobile application Humans, as well as individuals, who are users of the [kundalik.com](http://kundalik.com) website, who have committed actions listed in Section 2 of the Rules,

1.3 Territory of the Promotion is the Republic of Uzbekistan.

1.4 Period of Promotion is from 26.08.2022 and indefinitely.

### 2. Description of the Promotion

2.1 During the Promotion period and subject to these Rules, Promotion Participants have the opportunity to receive 100% cashback when paying for the web version of the Kundalik e-diary in the Humans mobile app and on [kundalik.com](http://kundalik.com) by selecting the "Humans" payment method.

2.2 The Promotion is open for Participants who are current Customers of the "Humans product and service showcase" service and whose use of the Humans service has not been suspended or terminated, as well as for current Customers of other Humans services (DUS/DBS).

2.3 During the period of the Promotion, a Humans user is subject to a cashback limit of 80 000 UZS per calendar year when paying for the Kundalik electronic diary.

2.4 The terms of the limit in paragraph 2.3 of these rules are applied to payments for all versions of the Kundalik electronic diary subscription made in the Humans mobile app and on [kundalik.com](http://kundalik.com).

### **3. Final provisions**

3.1 These Rules come into force from the launch of the Promotion. Humans has the right to unilaterally change these Rules, cancel the Promotion by notifying about it by posting the relevant notice on the Humans Website. The date of notification is the date the relevant information is posted on the Humans Website. The Rules are deemed to have been amended and the Promotion is deemed to have been prolonged or cancelled from the date of posting the relevant information on the Humans Website.

3.2 By making a payment to the Kundalik merchant in the Humans mobile app or on kundalik.com via the "Humans" payment method, the Participant fully and unconditionally agrees to the Rules, which are an offer addressed to individuals.
